

# Eagles send two wrestlers to state

MORRIS - The New Ulm Area wrestling team competed in the Section 3AA wrestling meet on Saturday at Morris Area High School, qualifying two wrestlers to the Class A State Individual Wrestling Tournament.

Ty Frederick (182) and Evan Thompson (285) both wrestled in the championship match.

Thompson finished second, with Brady Rhode of Dawson-Boyde-Lac Qui Par earning a 14-1 major decision.

Frederick finished second for NUA to qualify for state. Frederick went 4-1, falling to Hunter Gibson of Morris Area/Hancock/Chokio-Alberta at 2:26 in the championship match.

The individual tournament begins Friday at Xcel Energy Center.
